4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The All-round upholsterer is employed at companies which (re)upholster furniture. He/she is employed at furnituremakers, artisan upholstery companies or industrial companies the size of which can vary. The companies supply to private individuals, but also to businesses and government institutions. Furniture shall also be taken to include panels that are upholstered to have a positive impact on the room acoustics. The work mainly involves modern design sofas, armchairs, dining chairs and office furniture. There are also special target groups with furniture that must meet specific criteria. For example ship interiors, hospital furniture, furniture in nursing homes and wheelchairs. The (re)upholstery of classic furniture is carried out within a company focused specifically on this task. Depending on the type of company where the All-round upholsterer is employed, he/she is involved in the entire production process or parts of that process. At larger companies, it is possible that parts of the production process will be automated or that use is made of semi-manufactured goods. The All-round upholsterer supplies all types of (re)upholstered furniture, including non-standard processes.

<p>Access to next level of education/professions The All-round upholsterer can advance to Technical manager at level 4. He/she can also advance to work planning or the research department or start his or her own business. An alternative perspective within the labour market is expanding the field of work by switching to a related sector. For upholstery, this could be the textile sector.</p>	<p>International agreements All-round upholsterer is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The optional subjects have a total size of 15% of the course duration.
