3. PROFILE OF SKILLS AND COMPETENCES

Core task 1: Carries out replacement and repair work on non-structural parts of vehicles

- 1.1 Prepares the disassembly, replacement and repair work

Range of occupations accessible to the holder of the certificate

The bodywork industry consists of businesses (or parts of businesses) involved in repair work to (luxury) passenger cars, motorcycles, recreational vehicles (caravans, camper vans) and/or commercial vehicles. The bodywork sector also consists of businesses involved in (new) bodybuilding. The starting professional practitioner is specifically employed in businesses specialising in damage repair on (luxury) passenger cars and commercial vehicles. The starting professional practitioner performs his/her tasks in a workshop environment. The Skilled car damage repair mechanic works on both non-structural parts of vehicles and structural parts of conventional vehicle bodies.

Access to next level of education/professions The Skilled car damage repair mechanic has the opportunity to advance to the position of technical specialist car damage repair. He/she may follow supplementary training courses such as the study course for Technical specialist car damage repair or additional courses in diagnostics and (the functioning of) special systems / tools / materials. The Skilled car damage repair mechanic can also transfer to another level 3 qualification applicable to the bodywork industry, for example Skilled car spray painter. The Skilled car damage repair mechanic can also transfer to a position in a related sector such as All-round technician vehicles and mobile machines. For both career perspectives, it may be necessary to follow additional training / study courses. Skilled car damage repair mechanics continue their career outside the sector sometimes; for example in commercial or technical positions with suppliers/manufacturers of tools or in education (as car damage repair teacher).	International agreements Skilled car damage repair mechanic is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25884 The education and training for this qualification is offered as of 01-08-2023.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The complete qualification file can be found at <u>kwalificaties.s-bb.nl</u>, only in Dutch.

Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
