### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The All-round machine operator furniture industry/(ships') interior building is employed at a company in the timber and furniture sector specialising in the production of furniture and/or (ships') interiors or components/finished products in wood and sheet material used in construction or supplied for further processing to the furniture industry, interior building companies and other wood-processing companies. The companies supply to other companies and private individuals. He/she mainly works in the production department of the company or if possible on location in a building or on board a ship. The All-round machine operator furniture industry/(ships') interior building works with NC/CNC-controlled wood processing machines.

The All-round machine operator furniture industry/(ships') interior building can advance/broaden his skills to the position of Planner furniture industry/(ships') interior building.

### International agreements

Allround machine operator furniture industry and (ships') interior building is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

### Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25925 The education and training for this qualification is offered as of 01-08-2024.

### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

## Average duration of the education/ training leading to the certificate

3 years (4800 study hours) (depending on previous education)

### **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

### 7. Additional information

Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
