#### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Technician wood and restoration works in the civil and office and industrial building sector, the furniture industry and interior building and works at a variety of locations. This may include large building projects, smallscale building, redesign/renovation or restoration projects. He is employed with small, medium-sized or large construction companies, individually or as part of a small team. He works both indoors and outdoors. The Technician wood and restoration can undertake this work in paid employment or is self-employed.

Access to next level of education/professions The study course ties in perfectly with the traditional learning working pathway from pre-vocational secondary education (Building Living Interior) through to the study course Supervisor restoration (restoration professional) or the study course Specialist restoration Carpentry). Based on study and experience, the Technician wood and restoration can advance to various positions such as foreman/supervisor or an office position (work planner/calculator). He can also continue his career by becoming an independent contractor.	<b>International agreements</b> Technician wood and restoration is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

# Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
