4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Technician wood and restoration works in the construction sector, in restoration in a historical environment and/or the wood processing industry such as a furnituremaker or the carpentry industry. Possibly on (major) construction/restoration projects, small-scale construction, renewal/renovation projects or at a fixed location. The Technician wood and restoration can carry out his work in paid employment or self employed. Construction, restoration, machine woodworking, furniture making and interior carpentry are brought together in this one profession.

<p>Access to next level of education/professions Based on study and experience, the Technician wood and restoration can advance to various positions such as foreman/supervisor or an office position (work planner/calculator). He can transfer to the study course Specialist carpentry restoration, for example. He can also continue his career by becoming an independent contractor.</p>	<p>International agreements Technician wood and restoration is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The optional subjects have a total size of 15% of the course duration.
