The All-round kitchen mechanic works in the kitchen sector or the civil and industrial building sector, at or for an SME enterprise or a large company. This mainly involves working in paid employment or as a sole trader. The kitchen sector in its many forms serves a variety of customers and customer groups. The All-round kitchen mechanic is specialised in fitting and installing (custom) kitchens, organising and supervising the implementation of work by colleagues and providing service.

<p><b>Access to next level of education/professions</b> The All-round kitchen mechanic can among others transfer to a one-year senior secondary vocational education level 4 specialist study course in the field of entrepreneurship and management.</p>	<p><b>International agreements</b> All-round kitchen mechanic is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p><b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25956 The education and training for this qualification is offered as of 01-08-2024.</p>																					

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The optional subjects have a total size of 15% of the course duration.
