The Decoration and restoration painter is employed in the painting sector, possibly at companies specialising in restoration and decoration. In the context of decoration, this involves the painting of decorative elements to create atmosphere in an environment based on a design. In the context of restoration, it relates to the application and implementation of restoration painting techniques and restoration to wall paintings/monumental buildings and

Characteristics: non-job related skills such as tactical and strategic capacities. Access to next level of education/professions

The Decoration and restoration painter has a number of options for transfer to national and international higher professional education. Potential higher professional education study courses in the Netherlands are the arts academy, pedagogical technical university with a focus on Construction engineering, Higher professional education construction, Teacher visual arts and design, Bachelor cultural heritage and Bachelor conservation and restoration. Many students opt for international transfer mainly to Belgium because restoration-focused higher professional education study courses in the Netherlands are relatively rare.

International agreements

Decoration and restoration painter is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 27005 The education and training for this qualification is offered as of 01-08-2024.

6. Officially recognised ways of acquiring the certificate

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate

4 years (6400 study hours) (depending on previous education)

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

7. Additional information

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science.
