## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Journeyman glazier works (in paid employment or self-employed) at glazing companies and/or in the glass repair sector where he carries out work in maintenance and/or new building for a variety of clients in home, office and/or industrial building such as homes, office buildings and hospitals, or in the workshop. The Journeyman glazier independently performs tasks within various simple and more complex projects. He often fulfils the role of coordinator or manager and is responsible for practical project management and the supervision of students and/or new employees.

<p><b>Access to next level of education/professions</b> The Journeyman glazier (level 3) can advance internally to a management or specialist position or transfer to another follow-up study course at senior secondary vocational education level 4, for example in Finishing and Maintenance.</p>	<p><b>International agreements</b> Journeyman glazier is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p><b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25945 The education and training for this qualification is offered as of 01-08-2024.</p>																					

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>3 years (4800 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The optional subjects have a total size of 15% of the course duration.
