4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Skilled green, earth and green infrastructure worker works at a service company specialising in mainly mechanised work for the green, earth and green infrastructure sector. This sector covers a variety of work fields such as the primary agricultural sector and (public) outdoor spaces. The Skilled green, earth and green infrastructure worker in the primary agricultural sector is for example employed in service provision to horticultural, arable and dairy farms. In (public) outdoor spaces, the Skilled green, earth and green infrastructure worker is employed for earthmoving activities, the laying out and maintenance of public green areas, ice-control measures and/or green infrastructure operations. The Skilled green, earth and green infrastructure worker has a coordinating and observing role in the implementation of specialist activities. The Skilled green, earth and green infrastructure worker has a role in supervising the technical aspects of the work undertaken by Green, earth and green infrastructure workers.

However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The optional subjects have a total size of 15% of the course duration.
