**4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE**

The Supervisor green open spaces works in or focuses on outdoor spaces. This may include gardens, parks, forests, nature areas, water (features), recreation areas and/or landscapes. The Supervisor green open spaces can be employed in different types of organisations. He can be employed with an institution or government organisation, but also be self-employed or in paid employment with a private company. The Supervisor green open spaces is employed at a company or organisation in outdoor space. This includes site management organisations, water boards, government organisations, advisory bodies or a landscape gardener, a green space manager, a plant breeding company, a contractor or a recreation company. The Supervisor green open spaces mainly works on location and partly in the office. His work consists of organising the work of others.

The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.

However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).                  In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.                  In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>3 years (4800 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b>                  The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications.
