4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Made-to-measure shoemaker is mainly self-employed or works for small companies with a workshop and often a sales area. In most cases, these businesses specialise entirely in manufacturing new bespoke shoes or

repairing worn/used shoes and leather goods (handbags, belts and other leather products), often with the additional sale of related products. Increasingly, combinations are made with other activities or other forms of service provision (blurring). The Made-to-measure shoe maker (shoe developer) designs, manufactures and repairs shoes. This may be a pair of bespoke shoes for an individual customer, but the Made to-measure shoe maker can also have other clients for one or more pairs or shoes or for small shoe collections (for example fashion labels, a museum or the theatre world). The Made-to-measure shoe maker is generally self-employed (business owner) but may also be employed at the research & development department of shoe manufacturers or shoe brands in the Netherlands and abroad.

For example the HKU, design academy in Eindhoven, Artez in Arnhem. Another option is to continue via Industrial Footwear design at the Dutch Shoe Academy.</p>	<p>International agreements Made-to-measure shoe maker is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
