The Cultivation and green technology expert works at a farm with covered crop production, open crop production or a combination of these crop types. In the future this will also include new and alternative cultivation methods. The Cultivation and green technology expert can also be employed at a propagation farm or vertical farm. The Cultivation and green technology expert works in the office, performs desk work and if contributing actively works for example in greenhouses, halls and outdoors. The Specialist cultivation and green technology often works with a team and is a role model because of their managerial and guiding role.

<p><b>Access to next level of education/professions</b> Examples of transfer opportunities for the Cultivation and green technology expert are Higher professional education study courses Agriculture/Arable farming, Environmental studies and Applied Biology.</p>	<p><b>International agreements</b> Cultivation and green technology expert is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>3 years (4800 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
