The Agricultural trade and logistics expert works at a (wholesale) trading company, auction or production company involved in trade, transport, inspection and/or preparation (for auction) of primary products and/or food. The Agricultural trade and logistics expert works for example in the office, in halls, warehouses, auctions and sales areas. Large production companies often have multiple departments such as sales and marketing where the Specialist agricultural trade and logistics can be employed. The Agricultural trade and logistics expert has a managerial and guiding role.

<p><b>Access to next level of education/professions</b> Examples of transfer opportunities for the Agricultural trade and logistics expert are Higher professional education study courses such as Logistics.</p>	<p><b>International agreements</b> Agricultural trade and logistics expert is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>3 years (4800 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications.
