The Nutrition and lifestyle consultant works (in paid employment or self-employed) in organisations where nutrition and lifestyle play an important role. These can be weight loss studios, dietary clinics, fitness centres (dietary centres in) hospitals, municipalities (social domain) and care institutions. The Nutrition and lifestyle consultant can also work independently as a nutrition and lifestyle consultant for private customers, schools, company canteens, municipalities and businesses such as catering companies. The target group for the Nutrition and lifestyle consultant is very diverse: the elderly, children, young people, adults, athletes or specifically less active individuals.

The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.

However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The optional subjects have a total size of 15% of the course duration.
