4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Work supervisor care farm works in a business or organisation where animal care and/or green space activities are carried out in the framework of support work, social care, social activation or supervision (back) to work or education. The work environment is diverse, for example farms or horticultural businesses with an agricultural objective and (additional) care objective or care institutions that use animals or green space for care support. In all situations, care provision to participants is combined with elements from the green domain. The businesses or organisations in care agriculture offer different services such as daycare and temporary accommodation.

This document is designed to provide additional information about the specified certificate and does not have any legal status in itself. | <p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p> | |
