An Audio-visual specialist works for broadcasts, audio-visual and integrated media producers, publishers and advertising agencies, photo studios, (private) consumers, governmental institutions and facility companies among others and works under a steady contract, temporary contract or as an independent entrepreneur. In case of non-complex and/or small productions the Audio-visual specialist will carry out multiple or as many as possible

<p>Access to next level of education/professions An Audio-visual specialist can develop through other VET educations such as related educations within the qualification file Media design or within the qualification file Stage and event technology. He can also develop through higher professional education such as: Teacher course, Journalism, Film & television, Communication courses, Visual art & design and the Media & entertainment course. Furthermore, through work experience the Audio visual specialist can develop into specialised functions such as: cameraman, video editor, audio engineer, lighting technician and video engineer. He can also develop into supervising functions such as (assistant) production leader, project manager, coordinator, director or starting up his own business.</p>	<p>International agreements Audiovisual specialist is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The complete qualification file can be found at kwalificaties.s-bb.nl, only in Dutch.

Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
