The Employment agency intermediary works at an employment agency or similar branch involved in labour mediation (recruitment and selection agencies, reintegration office etc.). The agency where the Employment agency intermediary works may vary from an agency connected to a large (international) chain of employment agencies consisting of many offices, to a small, specialised employment agency consisting of merely one office.

<p>Access to next level of education/professions An Employment agency intermediary can develop to become a Senior employment office intermediary, (Assistant) Branch manager. The Employment agency intermediary can also do a higher professional education such as Human resource management, Law, Economy & law management, but the Commercial economy education is an option as well.</p>	<p>International agreements Employment agency intermediary is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
