The professional bears his or her own responsibility, which is not only related to practical implementation in terms of monitoring and supervision, but also a more formal, organisational responsibility. The range of tasks also includes drafting new procedures.

### Access to next level of education/professions

A Building site supervisor works within either the painting & maintenance branch of industry or the building completion branch of industry. He carries outwork for various clients within housing construction, utility construction and industrial construction (the real estate sector). This involves maintenance, restoration and renovation/construction projects. Generally he works in employment, where he carries out his tasks in a team. He can also work freelance. At a medium-sized or large enterprise, the Building site supervisor leads one or multiple projects, directs the project team and works together with the planner, the project leader and the supervisor.

### International agreements

Building site supervisor is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

### Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25014 The education and training for this qualification is offered as of 01-08-2015.

### 6. Officially recognised ways of acquiring the certificate

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

### Average duration of the education/ training leading to the certificate

3 years (4800 study hours) (depending on previous education)

### Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

### 7. Additional information

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science.
