The Gastronome/sommelier usually works within hospitality companies such as hotels, road restaurants, diners, catering companies and meeting/congress centres. Within these companies, service is paramount. Tasks, products and services are primarily determined by the customer's expectations, within the company formula. Based on his specialised gastronomic expertise the Gastronome/sommelier offers advice on combinations of drinks and meals.

A Gastronome/sommelier can also work in liquor acquisition or in a liquor store. Aside from that a Gastronome/sommelier can develop through related higher professional educations such as Viticulturist, Teacher in consumer technologies, International hospitality management or Higher hotel education.</p>	<p>International agreements Gastronome/sommelier is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
