4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

An All-round machine operator for wood working can work at companies processing various types of wood and sheet material through machine operation. He can work in the furniture industry, (ship) interior construction, carpentering, timber trade or wood article industry. The All-round machine operator for wood working can work on wooden/sheet product parts or finalised products which can be made with wood processing machines. It is possible these products are made on request.

<p>Access to next level of education/professions The VET-level 4 qualifications Technical supervisor or Planner are the most obvious ways to develop for an All-round machine operator for wood working. After graduating a VET-level 4 education, it is possible to receive further higher professional education in Engineering, Industrial product design or Human technology for example. The entrepreneurship education Skilled carpentering manufacturer of the Dutch carpentry industry union (NBvT) is a fully carpentering-based program, which is equal to a VET+ level.</p>	<p>International agreements All-round machine operator wood processing is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The complete qualification file can be found at kwalificaties.s-bb.nl, only in Dutch.</p> <p>Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration.
