4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Taxi driver generally works for a transport company (taxi company). The Taxi driver transports passengers in a passenger car or taxi bus (up to 8 passengers), possibly across the national border. The Taxi driver must have a valid driver card in accordance with the Driving License Regulations and the Passenger Transport Decree 2000. He must be able to provide a medical certificate and a certificate of good conduct and must have successfully completed the theory and practical exam.

5. OFFICIAL BASIS OF THE CERTIFICATE

The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.

<p>Access to next level of education/professions Career prospects for the Taxi driver consist primarily of transfer to coach driver, coach driver/travel guide or public transport driver. This requires completion of additional components of these courses. It is also possible within the company to progress or switch to an office position in the form of a planning or coordinating position (planner, controller). The Taxi driver can specialise as doctor's driver. 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.</p>
