3. PROFILE OF SKILLS AND COMPETENCES

Core task 1: Carries out nautical tasks

- 1.1 Determines the route
- 1.2 Sails and manoeuvres the ship
- 1.3 Moors/unmoors and anchors the ship
- 1.4 Is responsible for ship's administration
- 1.5 Matches operational nautical work with crew members

Core task 2: Acts as host on board the ship

- 2.1 Supervises the boarding and disembarkation process for passengers
- 2.2 Informs passengers and monitors the atmosphere
- 2.3 Checks tickets and carries out simple financial tasks
- 2.4 Matches the catering plan/sailing tasks with the operating staff

Core task 3: Is responsible for maintenance, cleaning and repairs on the ship

- 3.1 Carries out general maintenance work and repairs on the ship
- 3.2 Carries out minor mechanical maintenance and repairs on the ship
- 3.3 Cleans the ship prior to departure and following return

Core task 4: Prevents and acts in the event of incidents and disasters

- 4.1 Takes charge of accidents and disasters
- 4.2 Takes measures to prevent accidents and disasters
- 4.3 Provides assistance as required

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Skipper tour boat restricted operation area works in the tour industry. He makes boat trips or day trips on inland waterways with a ship carrying passengers. He sails on an Amsterdam canal type of tour boat. The ship has a length of less than 25 meters at the waterline and can accommodate the number of passengers permitted by the Human Environment & Transport Inspectorate. The ship carries no cargo and has no overnight accommodation, neither for the Skipper himself nor for passengers. The sailing area of the Skipper tour boat restricted operation area is mainly limited to the sailing areas in zone 4.

This document is designed to provide additional information about the specified certificate and does not have any legal status in itself. 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>
