<p>Access to next level of education/professions For the All-round make-up artist, career development options are usually within the profession itself, which generally involves acquiring and carrying out increasingly more complex assignments. Furthermore, the All-round make-up artist can supervise a group of make-up artists working within the same production. An All-round make-up artist can also specialise in areas such as making wigs, special effects or 3-D appliance. The All-round make-up artist can develop through another VET education such as the qualification Salon manager or All-round beautician. It is also possible to develop through higher professional educations such as Theatre design, Art & design, Art directions, Stage art production, Stage-technical production, Stagecraft or Drama teacher.</p>	<p>International agreements All-round make-up artist is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The complete qualification file can be found at kwalificaties.s-bb.nl, only in Dutch.</p> <p>Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.</p>
