## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The majority of the Medical pedicurists practises their profession as a sole proprietor. She has her own company or works ambulatory. The Medical pedicurist could be working in a group practice, healthcare institution, paramedic centre, health care centre, diabetic centre or in a multidisciplinary foot team in a hospital. Some Medical pedicurists are paid employees.

The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.

<p><b>Access to next level of education/professions</b>                  The Medical pedicurist could develop further within the field of pedicure concerning complementary and specialist treatments and by working in a multidisciplinary foot team in a hospital. Further progress is possible to positions such as educational instructor, manager, assessor as well as commercial positions with companies for foot care products and foot care materials. She could also become an independent entrepreneur. With additional education, a Medical pedicurist could become a Podotherapist for example. She could also advance through other paramedic courses such as Skin therapy and Physiotherapy.</p>	<p><b>International agreements</b>                  Medical pedicurist is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).                  In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.                  In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>3 years (4800 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b>                  The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications.
