## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Most All-round beauticians carry out their profession as a self-employed person without any employees (zzp). She owns her company or works as an ambulant. She could also be employed as a manager. Possible working environments are at a beauty salon, wellness centre, sauna, drugstore, or perfumery. The All-round beautician carries out specialist and complex treatments.

<p><b>Access to next level of education/professions</b>            An All-round beautician can become an educational trainer, expand her knowledge about wellness based and specialist treatments and develop her entrepreneurship. She could be advance to qualifications such as Medical pedicure and Salon manager. She could also follow further education at a higher professional education (hbo). The hbo courses Skin therapy and Physiotherapy reflect the qualification All-round beautician mostly in terms of contents. Following other hbo courses is also an option.</p>	<p><b>International agreements</b>            All-round beautician is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).            In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.            In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>3 years (4800 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b>            The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications.
