3. PROFILE OF SKILLS AND COMPETENCES

Core task 1: Preserves a position in an environment considered 'safe' for militaries

- 1.1 Prepares a military assignment
- 1.2 Makes and keeps him/herself ready for deployment
- 1.3 Prepares and maintains their equipment and material ready for deployment
- 1.4 Contributes to the security of the safe location
- 1.5 Acts with decision during incidents and calamities

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Junior military personnel are focused on a potential career as a serviceman with in a wing of the armed forces. He learns to undertake basic military tasks at barracks and in the military field. His work is aimed at learning to equip and man checkpoints, roadblocks, base guardhouses and guard posts. He also learns the basic principles of carrying out social patrols and reconnaissance patrols. He learns what it means to be battle ready. If following the training course he opts for a military career, he must be able to continue carrying out his tasks in a variety of dangerous, sometimes life-threatening circumstances. Junior military personnel must behave in accordance with the code of conduct of the Defence organisation, the requirements of military discipline and military hierarchy.

<p>Access to next level of education/professions The Junior military personnel prepares for a career within the Defence organisation. Following appointment, part of general basic training still must be completed. The positions in which Junior military personnel can end up are very diverse, from operational positions through to technical and logistic positions. He starts his career at the rank of Private. Junior military personnel can progress to the study course for junior military officer at level 3, the study course Security coordinator (he must first have obtained the certificate Security officer at level 2) or the study course Enforcer surveillance and security. Internal transfer within the Defence organisation to Junior officer level 3 is possible via previously acquired competences and (additional) training and is encouraged by the Defence organisation.</p>	<p>International agreements</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The complete qualification file can be found at kwalificaties.s-bb.nl, only in Dutch.

Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
