The Junior military officer carries out military duties in barracks and the (military) field, in and outside of the Netherlands. He can be deployed anywhere in the world in a wider variety of situations. The qualification Junior

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

military officer prepares for a career within the Ministry of Defence. The Junior military officer maritime can, should he meet the security requirements, surveys and selection requirements, be employed as a military and work for one of the departments of Defence. The Junior military officer will first and foremost work for one of the operational commands. When he is appointed by Defence and recruited by one of the operational commands, he will first follow an elementary basic training which will be followed up by a job training. The duties of a Junior military officer are on the crossroads between command and execution (middle management). He must be able to act as a commander on a lower execution level no matter whatever the circumstances. To be eligible for a work placement at the Ministry of Defence a certificate of good behaviour and a positive Sports Medical Advice must be produced.

<p>Access to next level of education/professions The training Junior military officer prepares for a career with Defence. The Junior military officer usually transfers to the Royal Army or the Royal Navy after the training. The positions in which he could land are quite diverse; it ranges from operational positions to technical and logistic ones. A vocational training Junior military officer allows the student after being appointed to be transferred to the non-commissioned military training where Junior military officers can continue their military training. He will be trained in the general military basics – parts of a technical training are also included. The Junior military officer can be promoted to the function of a sergeant (1st class), sergeant-major and adjutant Junior military officer. Outstanding Junior military officers can also be promoted to the highest military officer level: staff adjutant or to certain officer ranks. The Junior military officer can transfer to courses such as Coordinator security (a diploma security guard level 2 is a prerequisite), Enforcer supervision and safety, Sports coordinator and to different Middle Management officers courses such as construction.</p>	<p>International agreements Junior military officer is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
