The Skilled fast service worker works in fast service companies or catering organisations. There are many different fast service companies such as buffet restaurants, cafeterias, beach pavilions, ice cream parlors, coffee shops, tea rooms, bake-off companies, sandwich shops, lunch rooms, pizza takeaway, delivery companies and pancake restaurants.

<p><b>Access to next level of education/professions</b> A Skilled fast food service worker can develop to become a branch manager or manager/entrepreneur in fast food service through experience and further education. The Skilled fast food service worker can also develop horizontally to become skilled cook or a bartender.</p>	<p><b>International agreements</b> Skilled fast food service worker is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p><b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25176 The education and training for this qualification is offered as of 01-08-2015.</p>																					

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>3 years (4800 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
