## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

A Skilled car spray painter can work in the bodywork sector, mostly within companies specialised in damage repair of (luxury) personal cars and company vehicles. In these companies, the Skilled car spray painter carries out executive tasks within the preparation and spraying department.

<p><b>Access to next level of education/professions</b>          A Skilled car spray painter can develop through educations on their current level within the bodywork sector, i.e. Skilled car damage mechanic, Skilled car damage repair mechanic, Skilled bodywork builder or Skilled caravan mechanic. He can also develop through VET-level 4 qualifications, such as Technical manager or Aftersales manager mobility sector. A Skilled car spray painter can also continue his career outside of his sector; in commercial or technical functions at car paint suppliers and manufacturers or in the educational workfield (as car spray paint teacher).</p>	<p><b>International agreements</b>          Skilled car spray painter is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).          In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.          In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>3 years (4800 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b>          The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The optional subjects have a total size of 15% of the course duration.
