4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The All-round public space management worker can be employed by small, medium-sized and large organizations, including municipalities with their own field service, public companies and/or private companies. Private companies often work for local government (municipalities) and to a more limited extent for private companies.

The All-round public space management worker performs his work in a defined area in the public space. The work is aimed at making public facilities clean and tidy (paving, furniture, greenery, water features and works of art). Minor repairs are also carried out for the benefit of safety and use. However, he does not carry out specialist maintenance.

5. OFFICIAL BASIS OF THE CERTIFICATE

The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The optional subjects have a total size of 15% of the course duration.
