4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Decoration and restoration painter is employed in the painting trade, which may or may not be with companies specialised in the field of restauration and decoration. He carries out, depending on the company, painting working duties, restauration works and/or decorative tasks on buildings with an authentic atmosphere, such as churches and monuments or especially modern buildings. The working duties could be on both the exterior and interior of the buildings. A Decoration and restoration painter usually works on a payroll. He could also be employed as entrepreneur or a freelancer.

The Decoration and restoration painter can be promoted to one of the following positions: manager, entrepreneur, master painter, teacher, advisor, project leader, conservator and buildings archaeologist.</p>	<p>International agreements Decoration and restoration painter is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
