4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The (Ambulatory) project manager works for cleaning companies which aim at cleaning and maintenance of the interior, sanitary facilities and floorings in all kinds of sectors and/or at more specialist cleaning such as window cleaning, facade cleaning and cleaning after calamities. As an (Ambulatory) project manager, besides being active as an object leader, he is also occasionally active as a cleaner. The (Ambulatory) project manager could have properties such as one large hospital or several smaller ones in his custody.

It seems obvious for an (Ambulatory) project manager to be transferred to file Facility management on level 4. The (Ambulatory) project manager could also develop himself by means of courses to VSR-KMS auditor or inspector. He could also develop himself on the same level in the direction of more specialist cleaning.</p>	<p>International agreements (Ambulatory) project manager is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>
