### 4. Range of occupations accessible to the holder of the certificate

A Skilled industrial paint processor can work in the following braches of industry: industrial paint processing, yacht painting, furniture industry, timber construction, metal conservation or aircraft industry. In these branches wood, metal, synthetic or composite products are (spray)painted or coated. In industrial paint processing/coating, furniture industry or timber construction he works on metal, wood or synthetic construction, such as machines, furniture, domestic goods, bicycles & body work, (store) interiors and construction elements (window frames, doors stairs, etc.). In the metal conservation sector he conserves objects in the shipping industry, container companies and steel framework companies, which work on chemical installations, bridges, traffic constructions, artworks, and power pylons among others.

In yacht construction he carries out tasks involving both maintenance and construction of both the hull and interior of yachts.

In the aircraft industry he carries out tasks on both (parts of) the interior and exterior, including maintenance.

#### Access to next level of education/professions

A Skilled industrial paint processor can develop to middle management, which is achievable through the course Building completion, maintenance and interior (VET-level 4). Furthermore he can specialise by doing specialized courses in his area of expertise on VET-level 3.

#### International agreements

Skilled industrial paint processor is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

### Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25011 The education and training for this qualification is offered as of 01-08-2015.

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

## Average duration of the education/ training leading to the certificate

3 years (4800 study hours) (depending on previous education)

### **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

## 7. Additional information

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The complete qualification file can be found at kwalificaties.s-bb.nl, only in Dutch.

Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
