4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Coordinator sports, instruction, training and coaching is employable within a large field of sports, regular sports, less regular sports and 'new' sports. He can for this very reason be employable in a large scale of organisations. He is mostly employed by organisations which are primarily geared at sports and exercises such as sport organisations, fitness centres, sports centres and exercise centres. He can also be employed in outdoor sports organisations or other ones which combine sports, exercises and recreation and organisations in which sports and exercises are part of the professional activity such as defense, firefighting and police force. The Coordinator sports, instruction, training and coaching can also work for organisations in which sports and exercises are part of a council support plan, for instance. He strives to meet short term and long term objectives regarding the sportive and recreative performances of the participants and/or sportsmen.

5. OFFICIAL BASIS OF THE CERTIFICATE

Name and status of the body awarding the certificate

The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.

Name and status of the national/regional authority providing accreditation/recognition of the certificate Ministry of Education, Culture and Science

Level of the certificate (national or international)

Qualification level 4 of the Dutch VET qualification structure

Characteristics: non-job related skills such as tactical and strategic capacities. The professional bears his or her own responsibility, which is not only related to practical implementation in terms of monitoring and supervision, but also a more formal, organisational responsibility. The range of tasks also includes drafting new procedures.

Access to next level of education/professions

The Coordinator sports, instruction, training and coaching could move on to vocational education (hbo) and follow the course ALO or Physiotherapy. Further specialisation can be accomplished by means of sport organisations or sport unions. Sometimes he can pass for certificates or degrees issued by sports unions when taking a course named Coordinator sports, instruction, training and coaching. Sometimes exemptions are obtained or the degree Coordinator sports, instruction, training and coaching proves sufficient to meet the qualification requirements set by a sports union or sports organisation.

International agreements

Coordinator sports instruction, training and coaching is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25414 The education and training for this qualification is offered as of 01-08-2015.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate

4 years (6400 study hours) (depending on previous education)

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

7. Additional information

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The complete qualification file can be found at kwalificaties.s-bb.nl, only in Dutch.

Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
