4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE
The Plasterer is often employed by companies in the finishing industry, specifically in the plastering sector. He can also be self-employed. He carries out his work for various clients within the residential and non-residential construction sectors (both new construction and maintenance). Depending on the company, work may be concentrated on certain types of plastering work. He applies tin, paint and finishing layers to various surfaces (walls and ceilings).

5. OFFICIAL BASIS OF THE CERTIFICATE

Access to next level of education/professions

The Plasterer can specialise within the same level in particular types of plasterwork. This is possible through courses or training in professional practice. The Plasterer can also progress to the course Journeyman plaster (level 3).

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The complete qualification file can be found at kwalificaties.s-bb.nl, only in Dutch.

Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
