<p>The Gezel plasterer is often employed by companies within the finishing industry, specifically in the plastering sector. He can also be self-employed. He carries out his work for various clients within the residential and non-residential construction sectors (both new construction and maintenance). Depending on the company, work may be concentrated on certain types of plastering work. He applies tin, paint and finishing layers to various surfaces (walls and ceilings). Where appropriate, De Gezel plasterer also carries out decorative plastering work (decorative finishing layers, moldings and ornaments).</p>

<p>Access to next level of education/professions The Journeyman plasterer could be transferred to a middle management position such as executor, entrepreneur or restauration plasterer. This can happen through, for instance, a training Executive position dismantling, maintenance and interior (level 4) or technical courses.</p>	<p>International agreements Journeyman plasterer is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi).</p> <p>In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.</p> <p>In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The optional subjects have a total size of 15% of the course duration.
