4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Caravan mechanic works within the mobility sector in production or repair/maintenance. He works in companies that specialise in the construction and maintenance/repair of various vehicles such as (luxury) passenger cars, two-wheelers (motorcycles, scooters/mopeds and bicycles), recreational vehicles (caravans, campers, trailer tents) and / or commercial vehicles. He can also work at companies involved in bodywork (new) construction.

The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.

If the Caravan mechanic has the required competences, further advancement is possible to managerial positions such as head of new building or maintenance, workshop manager or even company manager. The Caravan mechanic can continue his career outside the sector; in commercial or technical positions at suppliers/manufacturers of caravan systems or in education (caravan mechanic teacher).</p>	<p>International agreements</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.</p>
