The Shoe repairman 3 works mostly in small companies with one to a maximum of several employees. He is an entrepreneur. The Shoe repairman 3 repairs shoes and leather goods and returns them as much as possible into their original condition in order to keep the fit, model, functionality and quality.

<p><b>Access to next level of education/professions</b> The Shoe repairman 3 can, if he is self-employed, decide to set up or take over several branches. If the Shoe repairman 3 obtains additional certificates or degrees, he could specialise in performing repairs on orthopaedic shoes and apply orthopaedic and shoe technical provisions. In addition, the Shoe repairman 3 could follow the course in Made-to-measure shoe maker.</p>	<p><b>International agreements</b> Shoe repairman 3 is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
