4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Concrete repairman is employed in the concrete repair industry. He works in civil, office & housing construction and road & waterway engineering. He works for private individuals and also large construction projects. He carries out all common non-structural concrete repair work.

The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.

5. OFFICIAL BASIS OF THE CERTIFICATE

Access to next level of education/professions

The certificate Concrete repair man grants access to level 3, the qualification All-round concrete repair man. The Concrete repair man can specialise in specific types of concrete repair work, via courses or training in professional practice. After completing additional training and demonstrating competences, the Concrete repair man can advance to higher positions in the concrete repair business such as foreman, supervisor, planner, calculator or company manager.

The education and training for this qualification is offered as of 01-08-2015.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate

2 years (3200 study hours) (depending on previous education)

Entry requirements

The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The complete qualification file can be found at kwalificaties.s-bb.nl, only in Dutch.

Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
