3. PROFILE OF SKILLS AND COMPETENCES

Core task 1: Carries out basic ground, waterway and road work

- 1.1 Sets up and maintains temporary traffic signs and barriers
- 1.2 Sets up and maintains work terrain
- 1.3 Takes measurements
- 1.4 Performs preparatory work
- 1.5 Lays hard surfaces
- 1.6 Puts work areas into agreed condition

Core task 2: Carries out general ground, waterway and road work

- 2.1 Applies and maintains drainage facilities
- 2.2 Lays road foundations
- 2.3 Installs/repairs sewer structures and maintains trenches
- 2.4 Lays verges
- 2.5 (Re)adjusts/places/lays/applies/repairs tires and gullies, surface boxes and pit edges, gutters and pavements

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The All-round skilled ground, waterway and road worker works in the ground, water and road construction sector, part of the construction infrastructure industry. He works for a small, medium-sized, large enterprise or as a freelancer. The All-round skilled ground, waterway and road worker is involved in the construction and maintenance of infrastructures. This concerns various road constructions, paving, hydraulic constructions, bank constructions and sewer constructions.

<p>Access to next level of education/professions Depending on the size of the enterprise, the All-round skilled ground, waterway and road worker can develop through further education and experience to become a foreman, supervisor or planner. He can also develop through middle-management functions in this branch of industry and through VET-level 4 education in the qualification structure such as qualifications from the Planning/implementation qualification file.</p>	<p>International agreements All-round skilled ground, waterway and road worker is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications.
