He can work at small, medium-sized or large building companies. Aside from standard carpentry tasks, the All-round carpenter can also carry out more complex tasks.

Furthermore, he can continue his work by becoming an independent contractor. Through education, it is possible to develop to VET-level 4 qualifications from the qualification file Planning/implementation.</p>  | <p><b>International agreements</b><br/>           All-round carpenter is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. | <p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).<br/>           In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.<br/>           In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p> |  |
