<p>The Assistant logistics worker works in all branches of the trade and transport sector, for example in a wholesaler, transport company, logistics service provider, distribution center, warehouse or production company. Depending on the size and type of company where he works, the range of tasks is broad or more specialised. It may happen that an Assistant logistics worker has to perform all tasks in the logistics process on a rotating basis and works throughout the warehouse or that he or she focuses on a specific task.</p>

<p>Access to next level of education/professions The Assistant logistics worker can enter all study courses at level 2. The Assistant logistics worker can progress within the same field to the level of basic professional practitioner as general or specialist logistic worker in a particular sector (for example the timber trade). Other opportunities for advancement are to the level of basic professional practitioner as warehouse worker, delivery service worker, driver in goods transport or port logistics worker.</p>	<p>International agreements</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements There are no legal educational requirements.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications.
