The Assistant process technology worker works in a wide variety of sectors within the process and manufacturing industry. He can work in both (petro)chemical and mechanical environments. In a simple sub process he often works on different devices, while in a complex process he is more likely to work on one device.

5. Official basis of the certificate

Access to next level of education/professions

The Assistant process technology worker can enter all study courses at level 2. The Assistant process technology worker can progress within the same field to the level of basic professional practitioner as operator A or operator production technology. It is also possible to switch to another sector in the process industry.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate

1 year (1600 study hours) (depending on previous education)

Entry requirements

There are no legal educational requirements.

7. Additional information

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The complete qualification file can be found at kwalificaties.s-bb.nl, only in Dutch.

Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
