4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Skilled combustion engine mechanic works in the workshops of combustion engine companies. These companies have specially equipped workshops for revision, maintenance and repairs. The Skilled combustion engine mechanic also often works at the customer's location. These are (large) diesel and gas engines for ships, generating sets, cogeneration plants for greenhouses and (mobile) equipment for example.

<p>Access to next level of education/professions There is a continuous learning path from the Skilled combustion engine mechanic to a Technical specialist combustion engines. In practice the Skilled combustion engine mechanic will not progress instantly, but gain some years of practical experience first before moving on to level 4 and only with the variant of combining work with study. The Skilled combustion engine mechanic could also progress through the one-year course 'Managing and craftsmanship' or to Aftersales manager for the mobility sector.</p>	<p>International agreements Skilled combustion engine mechanic is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
