4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

A Foreman management & maintenance public space (MPS) can be contracted by a small, medium-sized and large organisation, including municipalities with their own external service, public companies and/or private companies. These private companies generally work for local governments (municipalities) and for private enterprises to a more limited extent.

A Foreman MPS carries out tasks in a separate territory in public space, within diverse and dynamic situations and within more complex situations as well. Aside from his supervising tasks he also always carries out executive tasks himself. These tasks consist of cleaning and tending to public facilities (pavements, furniture, green, water features and artwork). He also carries out small repairs for the sake of safety and usability, although he does not carry out specialised maintenance.

This document is designed to provide additional information about the specified certificate and does not have any legal status in itself. The format of the description is based on the following texts: Council Resolution 93/C 49/01 of 3 December 1992 on the transparency of qualifications, Council Resolution 96/C 224/04 of 15 July 1996 on the transparency of vocational training certificates, and Recommendation 2001/613/EC of the European Parliament and of the Council of 10 July 2001 on mobility within the Community for students, persons undergoing training, volunteers, teachers and trainers.

Furthermore, a Foreman MPS can develop in this sector through courses and training.</p>	<p>International agreements Foreman management & maintenance public space is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
