## 4. Range of occupations accessible to the holder of the certificate

A Skilled worker equestrian sports and horse farm works at various types of horse farm companies or companies involved in sports and recreation such as stables for

sports/trade, livery stables and riding stables. The Skilled worker equestrian sports and horse farm generally provides daily care for the horses.

## 5. Official basis of the certificate

# Level of the certificate (national or international)

Qualification level 3 of the Dutch VET qualification

Characteristics: implementation of more than just the own block of tasks. The professional is able to account for his or her actions towards colleagues, and monitors and supervises the work of others. The range of tasks also includes drafting work preparation procedures. NLQF-niveau 3 - EQF level 3 - ISCED 3C

## Access to next level of education/professions

It is possible for a Skilled worker in horse farm to develop horizontally to companies which keep other kinds animals (such as dairy cattle, grazing livestock). It is also possible for him to develop to the qualification Manager equestrian sports and horse farm or to improve his riding and didactic skills and develop his own riding skill to become an instructor on a higher level.

## International agreements

Skilled worker equestrian sports and horse farm is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

## Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25470 The education and training for this qualification is offered as of 01-08-2015.

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

# Average duration of the education/ training leading to the certificate

3 years (4800 study hours) (depending on previous education)

## **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

## 7. Additional information

Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
