The Livestock farm worker works at a production company where animals are kept for milk, meat, rearing, eggs or fur or a combination thereof. He works in stables and in the open air, among other places.

The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.

5. OFFICIAL BASIS OF THE CERTIFICATE

Access to next level of education/professions

The Livestock farm worker can develop to become a Skilled agrarian contract worker or Skilled livestock farm worker for example. As a Skilled worker, he can also receive training in the animal testing sector, specifically for agricultural pets.

The education and training for this qualification is offered as of 01-08-2015.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate**2 years (3200 study hours) (depending on previous education)****Entry requirements**

The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The complete qualification file can be found at kwalificaties.s-bb.nl, only in Dutch.

Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
