Core task 1: Is responsible for taking care of the agribusiness product

- 1.1 Is responsible for the quality of the agribusiness product
- 1.2 Is responsible for the machinery, equipment and technical installations
- 1.3 Is responsible for the company buildings and grounds
- 1.4 Is responsible for information in the production chain

Core task 2: Takes care of agricultural contracting

- 2.1 Prepares machines and tools for use and operates them
- 2.2 Performs work for the cultivation of products/crops using machines
- 2.3 Monitors the planning on the implementation location
- 2.4 Attends to crop health

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Skilled agricultural contracting firm worker is employed by a contracting company and performs contract work at companies in primary production such as arable farming, horticulture and livestock farming companies. On the client's site he contributes to the production and/or transport of products/fertilizers/or management of land for nature development. The Skilled agricultural contracting firm worker usually works outdoors at various locations, with varying products and with a variety of (large) machinery.

An additional certificate is required to carry out the following activities:

- Mole and vole control - Certificate: MW (Mole and Vole control)
- Rodent control on agricultural companies - Certificate: KBA (Rodent control on agricultural companies)
- Carrying out crop protection - Certificate: Crop Protection A

The Skilled agricultural contracting firm worker can obtain these certificates within the training.

The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.

<p><b>Access to next level of education/professions</b>                  The Skilled agricultural contracting firm worker can develop to become a Agricultural contracting firm expert. He can also receive further education in the animal experimentation sector, specifically about agricultural pets, provided he works in the livestock sector.</p>	<p><b>International agreements</b>                  Skilled agrarian contracting firm worker is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).                  In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.                  In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>3 years (4800 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b>                  The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The optional subjects have a total size of 15% of the course duration.
