4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Biodynamic agriculture expert works on a biodynamic agricultural company. These can be mixed farms as well as separated farms in open cultivation, covered cultivation or livestock farming. Companies within biodynamic agriculture strive for closed cycles. These are naturally present on mixed farms. In the demixed company, the aim is to establish regional linking companies. The Biodynamic agriculture expert also focuses on optimising business activities based on an anthroposophical attitude to life. He has a leading and guiding role and is expected to stimulate the development and development of employees. The Biodynamic agriculture expert constantly pays attention to optimisation of the process, innovation and changes in the chain and the society around him.

The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.

Qualification level 4 of the Dutch VET qualification structure

Characteristics: non-job related skills such as tactical and strategic capacities. The professional bears his or her own responsibility, which is not only related to practical implementation in terms of monitoring and supervision, but also a more formal, organisational responsibility. The range of tasks also includes drafting new procedures.

Access to next level of education/professions

The Biodynamic agriculture expert can develop through higher professional educations such as Green, care an education (at agricultural schools such as Stoas in the Netherlands or Nature & communication.

International agreements

Biodynamic agriculture expert is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25439 The education and training for this qualification is offered as of 01-08-2015.

6. Officially recognised ways of acquiring the certificate

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate

4 years (6400 study hours) (depending on previous education)

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

7. Additional information

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The complete qualification file can be found at kwalificaties.s-bb.nl, only in Dutch.

7. Additional information

Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
