4. Range of occupations accessible to the holder of the certificate

The Green and land development worker can work at an institution or a government organisation, but he can also work as a self-employed person or as an employee of a private company. The Green and land development worker is involved with green, land and infrastructure tasks in public areas, focusing on sustainability and the social and economic function of the area. His routine work with machines and tools can range from earthmoving and soil work through to moving verges, sports fields and green areas.

The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

7. Additional information

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The complete qualification file can be found at kwalificatioss.sepb.nl, only in Dutch.

Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
